# (1) Evaluate Your Idea and Yourself

Before starting a business, you should examine your idea and your resources carefully.

- Why do you want to start a business?
- Is there a demand for the product or service you plan to offer?
- Are you a risk-taker who is ready and able to commit a lot of time and money to a business?
- Do you have a "support system" of people you can turn to for advice and help?

## (2) Write a Business Plan

Your business plan is the blueprint for your business. It describes your business, product, market, finances, and more. Banks and other creditors will want to review your business plan before offering you any financial support.

# (3) Create Your Business's Legal Structure

There are five basic business structures: sole proprietorships, general partnerships, corporations, limited liability company (LLC) and S-corporations. Read more about them and get the forms mentioned below from Business Link North Carolina, at edpnc.com/start-or-grow-a-business/start-a-business/business-structure/.

- To start a corporation (C-corporation), file Articles of Incorporation.
- To start a limited liability company, file <u>Articles of Organization</u>.

• A sole proprietorship is basically an extension of its owner's personal finances, so starting one does not

• Starting a general partnership requires a partnership agreement. The agreement should be in writing, and each partner should have a copy. This document does not need to be filed with a government agency.

• An S-corporation is created as a C-corporation, and then converted into an S-corporation using IRS Form 2553, Election by a Small Business Corporation, available online at www.irs.gov/pub/irs-pdf/f2553.pdf.

# (4) Name Your Business

Chose a name that is distinctive, says something about the nature of your business, and is easy to remember.

- A sole proprietorship can operate under the legal name of its owner and a general partnership can operate under the partners' last names. To give a business a name of its own, obtain a Assumed Business Name Certificate (available online from the Economic Development Partnership of North Carolina website, at edpnc.com/start-or-grow-a-business/start-a-business/business-forms/), get it notarized, and file it at the Guilford County Register of Deeds, at 325 E. Russell Ave, Room 155, High Point, NC 27260 (336.641.7556).
- Banks may require a Certificate of Assumed Name before creating an account for a sole proprietorship or partnership.
- Corporations, LLCs, and LLPs are named through the Corporations Division of the NC Department of the Secretary of State.

Avoid names that resemble existing businesses (otherwise you could confuse potential customers, make marketing harder, and create legal problems).

- Check the Corporations Division of the NC Department of the Secretary of State.
- Check Guilford County's Register of Deeds, at www.quilfordcountync.gov/our-county/register-of-deeds/ business
- You may also wish to check the US Patent and Trademark Office's database at www.uspto.gov/ trademarks/search. Taking this extra precaution is particularly advisable if you envision your business eventually expanding into other states.
- An online presence is essential for business. When selecting a name, think about whether it can be easily adapted into a web address, and whether it conflicts with the web addresses of existing businesses. Use the WHOIS database, at *www.networksolutions.com/whois*, to check for online conflicts.

# (5) Register Your Business with the City of High Point

Businesses which are physically located within the city limits of High Point are required to register with the municipal Revenue Collection Division and pay a \$25.00 registration fee. If a business has two or more locations, each one must register separately. Business registrations must be renewed annually. The registration year begins on May 1st and ends on the subsequent April 30th. The Application for Business Registration is available at www.highpointnc.gov/ BusinessRegistration. For more information, contact the municipal Revenue Collections Division, at 336.883.3205.

Businesses which are owned and operated by people with a occupational licenses issued by the State of North Carolina (such as doctors, dentists, and lawyers) are exempt from registration if those licenses require continuing education.

# (6) Zoning and Building Code Compliance

Determine where you will operate your business. BEFORE you buy a building, sign a lease, or purchase any equipment, contact the High Point Planning and Development Department (336.883.3328). Doing so will ensure that the structure you wish to use is zoned correctly and in compliance with the city's development regulations and the NC Building Code. # (7) Health Department and ABC Commission

Are you serving or selling food? Are you offering lodgings? Are you taking care of children? Are you running a swimming pool, camping facility, or tattoo/piercing studio? If so, contact the Guilford County Department of Environmental Health (336.641.3771) or visit https://www.guilfordcountync.gov/our-county/human-services/health-department/ environmental-health for standards, permit, and inspection information.

Are you serving or selling alcohol? For information about state permits, and to download permit application forms, go to the NC Alcohol Beverage Control (ABC) Commission website, at *abc.nc.gov/Permit/PermitTypes* (919.779.0700).

# (8) State Occupational Licensing

Many occupations require a license from the state. Before opening a business, make sure you (and/or any applicable employees) are properly licensed to do the work. A list of occupational licensing boards is available from the Labor and Economic Analysis Division of the NC Department of Commerce at www.ncbold.com/license.

# (9) Federal and State Taxes

Get your Federal Tax Identification Number (Employer ID Number, or EIN) from the IRS. Some sole proprietorships do not need an EIN (the owner uses his or her Social Security Number instead). If you think you may not need an EIN, contact Business Link North Carolina at 800.228.8443 or edpnc.com/start-or-grow-a-business/ to find out.

Businesses that sell products retail (as opposed to selling them wholesale or providing services) and/or have employees must register with the NC Department of Revenue and get a Sales and Use Tax Number. # (10) Employees

If you plan to hire anyone, you need to apply for an Employer Tax Account Number from the Division of Employment Security of the NC Department of Commerce. Go to *des.nc.gov*, and click on the "Help for Employers" link, under the "Online Account Help" heading (you'll need an EIN from the IRS to obtain a NC Employer Tax Account Number).

Each time you hire someone, you must notify the NC Directory of New Hires (maintained by NC Child Support Enforcement), at ncnewhires.ncdhhs.gov.

You must prove that each of your employees is permitted to work in the United States by completing and filing an Employment Verification Form (Form I-9) from US Citizenship and Immigration Services. Form I-9 (with instructions) is available at www.uscis.gov/i-9-central.

# (11) Market Your Business!

Let people know about you! Social media is a great, free way to publicize your business and interact with customers.

Use Facebook for Business (*www.facebook.com/business*). As a minimum, you should have a Facebook page for your business, which can serve as your website until you are ready to build a custom website. Include your hours, contact information, and lots of pictures. Post regularly and respond to questions promptly.

Other social media sites to consider include Twitter (business.twitter.com/en.html), Google (www.google.com/ business), and Instagram (business.instagram.com).

Traditional marketing can help, too. Consider newspaper ads, flyers, and targeted mailings, and remember the library can help you do this.

You can also apply for an EIN by downloading Form SS-4, Application for Employer Identification Number from the IRS website at www.irs.gov/pub/irs-pdf/fss4.pdf, filling it out, and then faxing it to 855.641.6935 or mailing it to Internal Revenue Service, ATTN: EIN Operation, Cincinnati, OH 45999.

You can also register using Form NC-BR, Business Registration Application for Income Tax Withholding, Sales and Use Tax, and Machinery and Equipment Tax, which is also available from the NC Department of Revenue website, at *www.ncdor.gov/media/10751/open*. Fill out the form online, download it, print it, and mail it to PO Box 25000, Raleigh, NC 27640-0100 (this is a "web fill-in" form -- forms filled in by hand
